## **Terms & Conditions**

### **Article 1. Definitions**

- Client: the natural or legal person with whom an agreement has been concluded with regard to the purchase of a product.
- Product: digital product with the aim of transferring and/or increasing knowledge and/or skills.
- Payment provider: company that takes care of the payment process for us.
- Conditions: these general conditions.

### **Article 2. Applicability**

1. Dutch law applies to every agreement between the Client and 'Circuits of the past' to which these general terms and conditions apply.
2. Exceptions to the conditions must be requested explicitly and in writing by the client and are only valid if they are subsequently confirmed in writing by 'Circuits of the past'.
3. A purchase of a product in the manner as stated in article 3 paragraph 1 implies acceptance of the applicability of these conditions.

### **Article 3. Registration and confirmation of program by private individuals**

1. Purchase of a product takes place by the client via the payment page hosted by our payment provider. By sending the completed form, the client agrees to these general terms and conditions.
2. After sending the registration form, a client will receive a confirmation email with an invoice from 'Circuits of the past'. By sending this confirmation email, the agreement to purchase the product is established.

### **Article 4. Prices**

1. When purchasing, the prices as stated on the website [www.circuitsofthepast.com](http://www.circuitsofthepast.com) apply.
2. When purchasing a product on the basis of a mailing or offer, the prices apply as stated in that mailing or offer.
3. The stated prices include VAT.
4. Prices can be adjusted due to unforeseen circumstances.
5. Prices will be adjusted in the event of changes in the VAT regime and/or the level of the applicable VAT rates.

### **Article 5. Payment and cancellation**

1. After purchasing a product via the form on the website, the client is directed to a secure payment page (which is hosted by our payment provider).

2. Payment of the entire amount must be made through the payment provider, whereby the amount is deposited into the bank account designated by 'Circuits of the past'.
3. The client is only assured of delivery of the product from the moment that the payment has been received by 'Circuits of the past'.
4. In the event of a reversal, the administrative costs will be charged (even if the relevant amount has not yet been transferred by the client).

#### **Article 6. Liability**

1. 'Circuits of the past' is not liable for any damage caused by participation in an activity of 'Circuits of the past' unless 'Circuits of the past' can be accused of intent or gross negligence.
2. If 'Circuits of the past' is at any time liable for any damage, despite the provisions of paragraph 1, this will be limited to a maximum of the invoice amount.
3. Indirect damage is not compensated by 'Circuits of the past'.

#### **Article 7. Intellectual property**

1. The products that are sent to the client are only intended for the client. The texts and images are subject to copyright.
2. Without the express written permission of 'Circuits of the past', the client is not entitled to disclose, exploit or, in any way whatsoever, reproduce or forward it to someone else.
